Tax-efficient giving:

Gift Aid is an invaluable source of “extra income”. If you are a UK tax-payer, giving to the Truro School Foundation (TSF) with **Gift Aid**, it will enable us to increase the value of your gift by up to 25% at no additional cost to you.

To make a **Gift Aid** donation, you must pay at least as much Income Tax as the amount of tax reclaimed by TSF. This is currently 25 pence for every pound donated.

Higher Rate Tax Payers
